## Families New to CCSD

## Age & Entrance Requirements

Children must meet the following minimum age and entrance requirements on or before September 30, 2015, to be admitted to kindergarten, first, or second grade.

### **Kindergarten**

Kindergarten students must have attained the age of 5 years old by Sept. 30, 2015.

### **First Grade**

First-grade students must have attained the age of 6 years old by Sept. 30, 2015 and demonstrate proof of completing kindergarten at a public, state-licensed private, state-exempt private, or approved home school program.

OR

Demonstrate proof of completing kindergarten and promotion to first grade while being a resident of another state in compliance with the age and entrance requirements of that state. Proof must be verified through a report card issued by the out-of-state public or private school.

### **Second Grade**

Second-grade students must have attained the age of 7 years old by Sept. 30, 2015 and demonstrate proof of completing kindergarten and first grade at a public, state-licensed private, state-exempt private, or approved home school program.

## Required Documents

Parents must provide the following documents to their child's school after completing online registration.

### **Proof of Address**

One form of proof of address is required. A recent utility bill, (telephone and cable bills are not acceptable), current mortgage statement, rental receipt, residential lease agreement, or sales contract are acceptable.

### **Proof of Child's Identity**

An original birth certificate, passport, or a certified birth card issued by a health district are acceptable.

### **Immunization Record**

Proof of immunizations must be submitted prior to your child attending school. For assistance with obtaining immunizations, parents may contact the Southern Nevada Health District. (702) 759-0852.

### **Parent/Guardian Identification**

A driver's license, picture identification, and/or passport are acceptable forms of personal identification.
